Humus refers to the fraction of soil organic matter that is amorphous and without the "cellular structure characteristic of plants, micro-organisms or animals.

It is stable. Much of the humus in most soils has persisted for more than a hundred years (rather than having been decomposed to CO2), and can be regarded as stable; this is organic matter that has been protected from decomposition by microbial or enzyme action because it is hidden (occluded) inside small aggregates of soil particles or tightly attached to clays.

Article 41- Right to work, to education and to public assistance in certain cases The State shall, within the limits of its economic capacity and development, make effective provision for securing the right to work, to education and to public assistance in cases of unemployment, old age, sickness and disablement, and in other cases of undeserved want.

Article 41 of the Constitution of India directs the States to provide public assistance to its citizens in cases of unemployment, old age, sickness and disablement and also in other cases within the limit of its economic capacity and development. It is in accordance with these noble principles that the Government of India on 15th August, 1995 included the National Social assistance Programme (NSAP) in the Central Budget for 1995-96.
